Faculty Senate Minutes December 7, 2010

The meeting was called to order at 4:09 p.m. All departments were in attendance except Athletics, Business Administration, Computer Science, and Interdisciplinary Studies.

VI. Report of the Administrative Officers

President

President McNairy noted that the presence of faculty at commencement is appreciated by the graduates. She announced plans for a Day of Advocacy and work with others across PASSHE to develop plans for effectively representing PASSHE and education needs to the legislature. Dr. McNairy reminded faculty of a reception in honor of Dr. Thomas Burns and thanked him for serving MU well as Associate Provost. Dr. Börger-Greco also expressed appreciation for Dr. Burns' diligent work with Senate.

Associate Provost for Academic Administration

Associate Provost Burns shared a list of new articulations with Cecil College of Maryland in the areas of nursing, earth sciences, physics, and chemistry and encouraged other fields to pursue similar articulations. [see Attachment #1] Dr. Burns noted low representation of retired faculty and staff on the page maintained by Faculty Senate and suggested other formats of recognition be considered. Several persons expressed interest in having access to information from the Wabash Study. Dr. Burns indicated that requests for specific details could be directed to Dr. Shibley and that seven key points from the study will be brought forward for discussion or integrated into work of AOAC or CAE on campus.

<u>Whereas:</u> Dr. David Hill served the Department of Psychology and Millersville University as an outstanding faculty member for more than 24 years from August 1986 until his December 2010 retirement; and

<u>Whereas:</u> Dr. David Hill was one of the founding members of the Psychology Departmental Honors Program and subsequently mentored a long list of Departmental and University Honors students; and

Whereas: Dr. David Hill served consistently for over 20 years on both the Undergraduate Committee and the Graduate Committee, including writing and grading the graduate Comprehensive Exams, interviewing aspiring candidates for admission to the graduate programs, serving on the Departmental Faculty Development Committee for many years (chairing the FDC for 2 years), serving on many individual faculty members' promotion and tenure committees, both inside and outside of the department, resulting in the successful promotion and tenure of many of them, and participating as a de facto "permanent member" of the Psychology Department Search Committee resulting in 12 successful tenure-track searches, and faithfully serving as the Departmental representative to APSCUF Representative Council for over 15 years; and

Whereas: Dr. David Hill continually worked to forge connections and collaboration between Millersville University and many community-based entities including the Millersville University Crisis Team, the M.U. Task Force on Alcohol and Other Drugs, mental health and drug/alcohol treatment programs, school districts, the Children and Youth Social Service Agency (CYA), Lancaster Family/Orphans Court, Pennsylvania Department of Education, and the Philadelphia College of Osteopathic Medicine, and culminating in the most recent 10 years by supervising the Directed Projects in Psychology course and creating the innovative Directed Projects Poster Session; and

Whereas: Dr. David Hill engaged in writing and research including posters, books, journal articles, and professional presentations, mostly in collaboration and coauthorship with students, and served as the research mentor on many Honors Theses and Master's Theses, and sat on a total of 12 doctoral dissertation committees (many former M.U. students); and

Whereas: Dr. David Hill masterfully taught 26 separate courses (13 undergraduate and 13 graduate) over 24 years of service in the department;

<u>Therefore be it resolved:</u> that the Department of Psychology of Millersville University thanks and congratulates Dr. David Hill for his outstanding contributions to the department, the School of Education, and the university community and wishes him much continued success and happiness; and further that the Department of Psychology recommends that Dr. David Hill be granted the honorary title of Professor of Psychology Emeritus.
