**Cohort Terms and Conditions**

The on-site M.Ed. Language and Literacy cohort program for York County is a year-round three-year program. Courses begin in Summer 2009 on-site at the Dover Area School District. The credits earned in these courses are applicable towards Millersville University's M.Ed. in Language and Literacy and the Reading Specialist Certificate.

Cohort participants must first be admitted into the M.Ed. in Language and Literacy program and must meet the following requirements:

- **Application for Admission** - Official application form for admission into Millersville University Graduate Studies. Applicants to all degree and certification programs use this application form.
- **Letters of Recommendation** - Three (3) letters of recommendation preferably from a supervisor or faculty member familiar with your work and academic background are required with application for admission.
- **Academic and Professional Goals Statement** - A signed academic and professional goals statement (approximately 300 words) is required with application for admission. The statement should include experiences which have influenced your decision to pursue post-baccalaureate studies and a self-assessment of your potential for advanced study and service in your chosen field.
- **Transcripts** - One (1) *official* transcript of baccalaureate and graduate work completed at **all** colleges or universities you have attended. Transcripts must bear the official institutional seal and be contained in a sealed institutional envelope. Millersville University graduates need not request a transcript.
- **Test Scores** - Official scores from the appropriate standardized test (MAT or GRE). The computerized MAT is administered on a weekly basis by the Millersville University Test Center. For more information about the MAT, please visit this link: <http://muweb.millersville.edu/~testctr>

Admission materials for the full-degree program must be submitted **by July 15, 2009** to be considered for the Cohort. Cohort participants must follow the program's course sequence as outlined on page two. There may be exceptions made for those who have a significant conflict in consultation with the Program Coordinator and Graduate Dean.

The first course offering for the 2009 Cohort is EDFN 511: Comparative Education. Participants are also encouraged to register for an on-campus or online. Possible on-campus electives being offered in the summer include the Writing Institute or the Gifted Institute. A non-degree admission application and registration form for EDFN 511 must be completed **by May 1, 2009**.
