**Note:** Transportation costs to and from the U.S. are not included. In addition to the above estimated costs, allowances must be made for educational and related expenses. Estimates for tuition, books, living expenses, and miscellaneous expenses for optional Winter and Summer terms are not included. Costs are subject to change. Living expenses include shared-room and a declining meal plan balance of \$2,100 per semester.

\* Lower tuition range reflects tuition reduction by \$6,000 per year for admitted freshmen's out-of-state tuition rate for a full-time course load. Admitted transfer students' out-of-state tuition rate is reduced by \$4,000 per year for a full-time course load.

If funds are in a currency other than US dollars, we can do the conversion.**
