#### What is your name and title?

#### How long have you been at MU?

### Four Online Learning Tips for Student Success

- Create a schedule and manage your time wisely. Keep a semester & a weekly calendar. On the first day of the class, read the course syllabus and enter all due dates in your calendar, along with reminders for due dates. Commit to studying or participating in your online class for at least 3 hours per week for every credit hour the course is worth.
- Stay organized and be thorough. Have a designated study space that is free of distractions so you can focus on your work. Prepare as if you have to teach the information you are studying.
- 3. Remain engaged throughout the whole course. Prepare & review for every lesson and attend in person/virtual class ses-

sions. Analyze all returned quizzes and tests as well as any instructor feedback & develop a plan for improvement.

 Know where to turn for help. Make use of your instructor's and your advisor's office hours. All of MU's student resources, including Learning Services and the library are available to online students.

## 2024-2025 FAFSA Update

The FAFSA Simplification Act was passed by Congress and represents a significant overhaul of the processes and systems used to award federal student aid. This includes the Free Application for Federal Student Aid (FAFSA) form, the need analysis that determines aid eligibility, changes in terminology, and many policies and procedures for schools that participate in federal student aid programs.

Despite the well-intentioned reforms, the transition to the new financial aid framework has presented challenges for students and families nation-

1. Complete the FAFSA application: Don't wait! The sooner you submit your FAFSA, the sooner you'll know what financial aid you qualify for. Our Financial Aid team is here to help you through the process and answer any questions you may have. STUDENTAID.GOV/FAFSA wide. While the intention behind these changes is positive, the rollout from the Department of Education (ED) and Federal Student Aid (FSA) hasn't been without its challenges. Some of the prevalent issues include:

- Implementation & Rollout Delays
- Technical glitches
- Communication gaps

The transition to the new FAFSA Simplification Act has presented unforeseen challenges, resulting in delays in processing financial aid applications. Students and families may experience

frustration and uncertainty as they await decisions on their aid packages. Additionally, technical glitches and system updates have further exacerbated delays, impacting timely access to critical financial assistance.

Despite these challenges, it's important to recognize the long-term benefits of the FAFSA Simplification Act and Future Act. While the initial implementation phase may be challenging, the streamlined process will ultimately make it easier for students and families to access financial aid in the future.

### Withdrawing from a Class

There is a drop/add period at the beginning of each semester. Please check the appropriate academic calendar for the drop/add deadlines for each semester. If you are registered for a course that begins and/ or ends earlier or later than the standard semester, these deadlines will vary. For deadlines for specific classes, go to millersville.edu/ registrar/scheduleandregistration/ drop-add-withdraw and choose the appropriate semester.

If you need to withdraw from a class after drop/add has ended, you will need to complete a Request to Withdraw via MAX. You may or may not be entitled to a refund depending on the date you withdraw from the class. There is a link to the Request to Withdraw form at the previously mentioned website.
