

## Millersville University of Pennsylvania Crime Rates and Statistics

This report, prepared by the Millersville University Police, is published in compliance with Pennsylvania Act 1988-73, the College and Security Information Act. The crime rate is computed as follows: the number of crimes in each category is divided by the gross number of full-time equivalent (FTE) students and employees. For example, in 2007, the University had 7,058 FTE students, employees, and 21 known burglaries. To calculate the crime rate: 21 burglaries for 7,058 FTE= .00273 burglaries per FTE or 6.2 incidents per 10,000 population.

- 7 In 2006, two (2) rapes were reported. One (1) occurred in another jurisdiction and one (1) victim declined investigation.
- 8 In 2005, three (3) rapes were reported. One (1) occurred in another jurisdiction turned over for investigation and one (1) was closed by the victim's prosecution waiver.
- 9 Staring 2005 all burglaries comply with the Clery definition.
