The Clarence Schock Foundation Scholarship is awarded annually to Millersville University freshmen on the basis of **scholastic record, financial need as determined by the Free Application for Federal Student Aid (FAFSA), and personal attributes**. Only high school graduates from counties served by the Clarence Schock Foundation are eligible. To be considered for the Clarence Schock Foundation Scholarship, you must meet the following criteria:

1. Be a legal resident and currently enrolled or a graduate of a secondary school in the following Pennsylvania counties: Adams, Berks, Chester, Cumberland, Dauphin, Delaware, Lancaster, Lebanon, and York.
2. **Complete and submit the Clarence Schock Foundation Scholarship application by Friday, February 24, 2012** to: Office of Financial Aid, Millersville University, P.O. Box 1002, Millersville, PA 17551-0302.
3. **Complete and submit the 2012-2013 FAFSA by February 24, 2012**. The FAFSA can be completed online at: www.fafsa.ed.gov. It cannot be completed prior to January 1, 2012. Be sure to list Millersville University as a school to receive the information – our school code is 003325. If you wish to submit a paper copy, you must contact Federal Student Aid at 1-800-433-3243 to request a paper FAFSA be mailed to you.

***PLEASE NOTE:** Determination of financial need will be based on figures as noted on the 2012-2013 Free Application for Federal Student Aid (FAFSA). If those figures change, the Office of Financial Aid reserves the right to rescind the Clarence Schock Foundation Scholarship.*
