- 1. Review and Approval of Minutes:

- 3. Graduate Curriculum and Policy Proposals:
 - a. SOWK 774 New Course Proposal
 - i. Comprehensive paper course was being taken as part of an existing course. Now it is a standalone course.
 - ii. Doc students need encouragement to write at a higher level.
 - iii. B. Mowrey moved. O. Dreon 2nd. Approved.
 - b. Review of how to find new proposals/CAP
 - i. T. Wright conducted a live online demonstration.
 - ii. CAP link is on the Associate Provost's web page.
 - iii. Only T. Wright has access to the dashboard. Everyone has access to proposals but not drafts.
 - iv. Proposals have two-week window for comments.
 - v. This is a new and better system. Benefits are:
 - 1. Record access
 - 2. Record history
 - 3. Transparency
 - 4. Expedition
 - vi. There is a CAP meeting next week, so issues found can be discussed there.

4. Old Business:

- a. GAAC Governance Policy
 - i. Old policy found from 2010 that we were not using. A new policy is advised. We were using a procedures document.
 - ii. There should be more formalization. This is especially advised in case of legal issues.
 - iii. Middle States requires an open & transparent grievance policy.
 - iv. Subcommittee will create a rough draft policy. Members are N.
 Pfannenstiel, O. Dreon, L. Granruth, C. Wolfgang and T. Washington. J.
 Delle will deliver to Faculty Senate.
 - v. Institution memory is important.
 - vi. The undergrad policy is more formal and makes a good model.
 - vii. Should the Graduate Dean be part of the appeal?
 - viii. It was suggested to write in as much flexibility as possible.
 - ix. An appointed group of 5 members with 3 alternates is most agreeable to the group.
 - x. It was noted there is too much pressure to get appeals done quickly.
- b. Admin Support in Graduate Admissions

- i. Grad Admission is now in Academic Affairs. C. Baker now reports to the Graduate Dean.
- ii. There is no permanent staff assistant. With one GA and three student workers rotating in there is little consistency and at times a lack of coverage.
- iii. A letter of support will be created for this effort. Data would be helpful if added. C. Baker is checking on other PASSHE school structures. J. Delle will deliver.
- iv. Some restructuring is already planned for the CGSAL unit.
- c. Writing Center Updates
 - i. An English Dept GAs is assisting with this effort of more support for graduate students.
 - ii. The goal is user friendly resources. The center does a "triage" service for incoming requests.
 - iii. O. Dreon shared a link from Indiana University on plagiarism. Included is a testing tool. A challenging test but it includes a certification at completion. Some of our doc students are currently using it.
