1. **Fall 2020 Student Organization Readiness Survey** - We created a survey to gauge your thoughts about the fall 2020 semester. We highly encourage you to complete this survey **by Wednesday, August 12th** so that Campus Life can best support you and your student organization moving forward. Follow [this link](#) to the survey. It will take you 10 minutes to complete, but it is vital for us to get this feedback. In appreciation for participating, all students who complete the survey by midnight on Wednesday, August 12th will be entered into a drawing for one of two \$25 Amazon Gift Cards. At the end of the survey, you will be asked to enter your information. *This survey is ANONYMOUS. Your information will only be used to contact you should you be selected to receive one of the incentives. Your information will NOT be associated with your responses on the survey.

2. Reminder: The **Activate Your Org** process must be completed **by Wednesday, September 16, 2020** in order for your organization to remain active for the 2020-2021 academic year. If you have any questions about where you are in this process, please email campuslife@millersville.edu, or call 717-871-7056. Please be sure to start AND complete this process by September 16th. If you do not begin this process by September 16th your organization will be locked and denied all services until the start of the spring 2021 semester. If you have begun, but not yet completed, the Activate Your Org process, your organization will be frozen until all requirements have been fulfilled. Here are the [step by step instructions](#). 3. **D2L Training**, which is part of the Activate Your Org process, is now live! Each organization's President and one other officer are required to complete the Title IX training hosted on D2L. In the online registration portion of Activate Your Org 2020-2021 we asked for your two members that will be completing this training. Those names have been added to the D2L course. **D2L Training must be completed by Wednesday, September 16, 2020.**

4. Campus Life is now recruiting for the (virtual) **Emerging Leaders Program**. All students who are interested in enhancing their leadership development skills are invited!
