

RETURNING STUDENT CALENDAR

OCTOBER

- Complete the [FAFSA](#) early (available October 1 as) for maximum consideration of all available student aid programs.
- Once you complete the FAFSA You will receive an email with a link to your Student Aid Report. Read it thoroughly and make any necessary corrections. If no corrections are necessary, keep it for your records.

NOVEMBER

- Financial Aid Scholarships become available at the end of November. Keep an eye out for scholarship applications to be available on the [Scholarships](#) section of the Financial Aid website.
- Complete the [FAFSA](#) early (available October 1 as) for maximum consideration of all available student aid programs.

DECEMBER

- Complete the [FAFSA](#) early (available October 1 as) for maximum consideration of all available student aid programs.
- Begin completing scholarship applications for the upcoming academic year. Make sure they are submitted by the deadline on the form and all requested information is submitted with it.

JANUARY

- Complete the [FAFSA](#) early (available October 1 as) for maximum consideration of all available student aid programs.
- Begin completing scholarship applications for the upcoming academic year. They are available online in the [Scholarships](#) section of the Financial Aid website. Make sure they are submitted by the deadline on the form and all requested information is submitted with it.

FEBRUARY

- Deadline for Millersville [Scholarships](#)
- File the [FAFSA](#) early. Priority filing deadline is March 15 for Millersville University.
- State Grant deadline is no later than May 1
- Complete any outstanding requirements to ensure your financial aid is processed. If you have outstanding verification items, your financial aid will not pay.

MARCH

- Complete the [FAFSA](#) early (available October 1 as) for maximum consideration of all available student aid programs.
- Priority filing deadline is March 15 for Millersville University.
- State Grant deadline is no later than May 1

APRIL

- Access information regarding payment plans. Millersville has a ten-month payment plan called TMS. There is a deadline of June 1 (for the annual option or the fall only option) and November 1 (for the spring only option).
- Parent PLUS Loan becomes available for upcoming academic year.
- Summer Aid Applications are available April 1

MAY

- If you haven't filed the [FAFSA](#) do it soon, so that you can be packaged with Financial Aid in June.
- Deadline for PHEAA State Grant (The FAFSA must be received by the processor by this date, not postmarked!) - MAY 1
- Complete any outstanding requirements to ensure your financial aid is processed. If you have outstanding verification items, your financial aid will not pay.

JUNE

- Returning students are packaged with Financial Aid so long as all other requirements are met.
- Check your e-mail for information about your awards.
- Deadline to sign up for the [payment plan](#) to pay your bill for the fall semester is June 1.
- Consider other types of financial aid necessary to pay your bill, including the [Federal Parent PLUS Loan](#) or [Alternative Loans](#). Do not wait until August to apply for these additional funds. Doing so may

JULY

- Fall semester bills go out mid to end of July. As soon as E-Bills are ready, an email notification will be sent to your millersville.edu email address. Parents and others with Third Party Access will receive email notification at the email address provided.
- E-Bills should be reviewed to determine if there is a remaining balance due.
- Make sure you have enough financial aid to cover your bill. If not, contact the Office of Financial Aid for more options.

AUGUST

- FALL BILLS ARE DUE!**
- Make sure to pay your bill with the Office of Student Accounts (OSA) to avoid a \$100 late fee and a hold on your registration.
- If you are expecting a refund, make sure to sign up for [Direct Deposit](#) for a quicker and more secure delivery of your refund!
- Please see the Office of Student Accounts (OSA) web site for additional information on [paying your semester bill](#).
- Classes start at the end of month.

SEPTEMBER

- Financial Aid is disbursed after the Add/Drop period for classes and refunds are mailed for students who have an overpayment of financial aid.
- If you are expecting a refund, make sure to sign up for [Direct Deposit](#) for a quicker and more secure delivery of your refund!

OCTOBER

- Next year's FAFSA becomes available October 1
- Spring semester bills will be available mid-November
- Spring semester bills will be due early December
- Get ready to start the process all over again!
