APPEAL LETTER

You MUST provide the Financial Aid Committee with a typed and signed letter that includes the following information:

 - Lack of knowledge of the Financial Aid Satisfactory Academic Progress Policy is not a reason for reinstatement of aid, as this policy is provided with financial aid awards and is posted on the website.
2. Describe in detail what has changed in your situation that will allow you to make Satisfactory Academic Progress at the next evaluation.
 - If you have used any academic resources such as (1) Academic Advisement, (2) MU Counseling Center or (3) Learning Services, please attach proof that you have registered for and/or used these services.
3. Provide appropriate third-party documentation to verify/support the claim(s) you make in your appeal letter.
 - The letters must be from a third party who does **not** have a direct relationship with the student. This must be a **professional individual** such as: a letter from a doctor, counselor or psychologist, social worker, police, copies of obituaries, news articles, records of hospitalizations, etc.
 - Each letter must be on official letterhead, signed and include the individual's name, title, telephone number and relationship to the student.

Include within your appeal letter your Academic Recovery Plan:

1. Outline your academic plan (as discussed with your advisor) that will ensure improvement before your next Satisfactory Academic Progress evaluation.
 - Please provide the committee with more than just your schedule for the upcoming semester. Give an explanation as to why you are taking those courses and how it will enable you to be successful.
2. What other responsibilities do you have while attending MU?
3. Who and/or what serves as your support system in your efforts to make academic progress? Describe how you have modified your behavior/circumstances to assure your successful academic future here at MU.

Your appeal will be reviewed in the order it is received. Please allow 8-10 business days for review once all documentation is received. You will be notified if you have been approved to receive aid for the 2022-2023 academic year. The last day to submit an appeal for the fall 2022 semester is Friday, August 5, 2022. No exceptions will be made for appeals submitted after this date.

- _____ 1. I certify that all the information and documentation submitted in this appeal is accurate and true to the best of my knowledge.
- _____ 2. I understand that the submission of this appeal does not guarantee reinstatement of my Federal (Title IV) financial aid.
- _____ 3. I understand that if I am beginning enrollment in the Fall Semester and my documentation is **not received by the priority deadline of July 6, 2022 that there is no guarantee that my appeal will be reviewed prior to bill due date for the fall semester**. I understand that the last day to submit an appeal for the Fall 2022 Semester is Monday, August 22, 2022. No exceptions will be made for appeals submitted after this date.
- _____ 3. I understand that if I am beginning enrollment in the Spring Semester and my documentation is **not received by the priority deadline of December 21, 2022 that there is no guarantee that my appeal will be reviewed prior to bill due date for the spring semester**. I understand that the last day to submit an appeal for the Spring 2023 Semester is Tuesday, January 17, 2023. No exceptions will be made for appeals submitted after this date.
- _____ 4. I understand that if a decision about my appeal has not been made by the billing due date or if I did not submit my appeal by the priority deadline, I will have to make payment arrangements with the Office of Student Accounts (OSA). I understand that my appeal could be denied.
- _____ 5. I understand that appeals based on being unaware of the Satisfactory Academic Progress Policy will not be considered, as this is not an extenuating circumstance the policy is provided with financial aid awards and is posted on the website.
- _____ 6. I give permission to the Financial Aid Committee to review my financial aid records, my academic records and my judicial affairs records that are on file at Millersville University.
