- Elections

6. Officers

a. The following officers shall be elected from the UCAPC membership at the first meeting of each spring semester:

- President
- President Pro Tempore, who shall preside in the absence of or at the request of the President of the UCAPC.
- Secretary; duties other than those normally pertaining to the office of secretary shall be specified in the bylaws
- Parliamentarian, who shall be appointed by the President of the UCAPC.

b. All officers shall serve a three-year term. The first set of elections under this provision shall be staggered as follows:

- President, Spring 2025
- President Pro Tempore, Spring 2026
- Secretary, Spring 2027

c. All officers shall begin their terms on the first day of the fall semester following their election/appointment.

d. Should an office be vacated prior to the end of the regular term, the membership shall elect someone from the UCAPC membership to serve out the remainder of that term.

 - end of September** for Fall courses (next calendar year)

 - end of November** for Summer courses (the next calendar year)
