# Faculty Senate Minutes March 5, 2019

The meeting was called to order at 4:11 p.m. All departments were in attendance except Counseling & Human Development, Educational Foundations, Interdisciplinary Studies, and Library.

# I. Minutes of previous meeting

An R. Baker/Halawa motion to amend the minutes so the motion regarding the curriculum framework reads "to endorse submission of a curricular framework for a BS in Sports Administration degree to PASSHE" was approved without dissent.

# II. Proposed Courses and Programs

Discussion was held regarding the mechanism for considering curricular frameworks for submission to PASSHE. A template structure was distributed, and standard language will be used for Senate endorsement. Departments who will develop the curriculum should request endorsement of framework submission by way of a motion.

# VII. Report of the Administrative Officers

## **President**

President Wubah discussed new academic programs, a decrease in funding for merit scholarships, and efforts to improve budgeting strategies. Dr. Wubah noted a new VP of Advancement will be selected soon to begin this summer along with a new Chief Diversity Officer. He also commented on PASSHE issues of sustainability, noting that Chancellor Greenstein will be returning to campus to discuss changes. Dr. Wubah requested that faculty consider serving on related bodies looking into academics, finances, and student success and retention.

# **Provost**

Provost Prabhu encouraged faculty to attend the presidential inauguration April 18 at 11 a.m., providing permission for faculty to promote or facilitate attendance by themselves and their students. Dr. Prabhu explained how PASSHE changes to program review have created a short-term process for programs currently in the pipeline for review. After those proposals are cleared, PASSHE will transition to a new role for the Chief Academic Officers to make program approval recommendations to the PASSHE BOG.

# **EYASC**

Senator Cook presented proposed changes to the Educator of the Year Award Selection Committee bylaws. The proposal reflects the charge to Joint Senate Conference Committee to provide oversight to EYASC, designating the Faculty Senate Chair Pro Tempore as non-voting EYASC chair. These changes should provide continuity in organization so that EYASC members can focus on selection of the awardee each year.

# **JSCC**

Senator Cook presented proposed changes to the Joint Senate Conference Committee bylaws. The proposal clarifies the charge of Joint Senate Conference Committee, including oversight of EYASC, and adds a graduate student representative.

# **GERC**

Senator C. Smith shared that GERC has developed a 1-2-year plan for reviewing General Education. Due to difficulties that arose during the last major review, Dr. Smith requested some clarification about how the final proposal would be reviewed and expectations for voting.

## **GCPRC**

Dr. Tiffany Wright distributed a proposed change to the Clinical Competency Review policy. She also noted that the graduate open house has been rescheduled and feedback on graduate student writing needs are still being collected.

## **UHC**

Dr. Aaron Haines requested that 500-level graduate courses qualify as an H designation for students earning a B- or higher. He noted that Honors College students would need to follow the current process for admission to graduate courses.

Mr. Sciarretta also noted that localized student success centers are being developed to enhance student access to advising support.
