- a. Dr. James Delle, Associate Provost
 - i. Catalog
 1. Being finalized for 2022-23.
 2. Have not yet incorporated new curriculum data in Banner as of 2022 Spring.
 3. We will be redoing catalog exercise in Spring 2023 for 2023-24 so that it can be published before the academic year. This will be the schedule moving forward.
 - ii. Dr. Delle fielded questions regarding new state level GenEd transfer policy and whether all credits transfer if they have completed GenEd but not complete AA or BA. See policy below.

XI. Reports of the Faculty Senate Standing Committees

- a. APC, Dr. David Owen, Member
 - i. Credit Bearing Internship Policy Revision
 1. Shared a copy of proposed changes, mostly made to clear up unnecessary language.
 2. Questions: Why the limit of 12hrs? Should we consider a 15 credit limit? Feedback from departments is requested.
 3. It was noted that that Co-op committee should also review any changes to this policy.
- b. GERC, Dr. Jeff Wimer, Chair
 - i. GenEd Voting Policy Discussion and GenEd Review
 1. Suggestion #01 - A voting procedure of two online campus votes with full faculty votes.

- a. Primary vote – Model A vs B, to determine new GenEd model.
 - b. Secondary vote – Model is voted on yes/no compared to old GenEd.
 - 2. Suggestion #02 - Vote to change, if yes, then model A vs B.
 - 3. Suggestion #03 – Ranked choice model.
 - 4. Suggestion #04 - Representative democracy option, senate decides what model goes forward, department votes prior to senate vote.
 - 5. It needs to be clear on what we are voting on. Learning outcomes, major components, etc. More detail the better.
 - 6. Need to clarify other components such as quorum thresholds, voting majority thresholds, etc.
 - ii. Middles States accreditation does not have a requirement to change GenEd, only some recommendations to make some changes.
 - iii. We still could incrementally change GenEd.
 - iv. GERC will return with a formal voting proposal. Pass feedback to GERC by Thursday for next meeting.
- c. UCPRC, Dr. Aileen Hower, Chair
 - i. During the previous recertification process some decertifications were missed. These will need to be approved through CAP like any other curriculum change. Departments and chairs may get notification from UCPRC of need to put these proposals into CAP.
