## How to Read the Continuing Education Pay Chart – Spring 2023

---

*Continuing Education (CE) pay is based on rank/step and enrollment.*

*This instruction is based on a three-credit course.*

1. Locate the undergraduate or graduate course pay chart.
2. On the right side of the chart, locate your current rank/step (column D); then follow the row across to locate your maximum salary for 3 credits (column G). This is the most you can make teaching a three-credit course via the CE pay scale.
3. On the left side of the chart, locate the number of students you have enrolled in your course. Follow the row across to the associated gross salary for 3 credits (column B). This is the amount you will be paid for the course unless it exceeds your maximum salary as determined in step 2.

The amount listed in the chart is gross salary not net salary.

*The enrollment number that informs this agreement is based on the course enrollment the morning after the drop/add deadline.*

Example:

Professor Jones has a rank/step\* (column D) of 1-01. His maximum salary for his 3 credit undergraduate course (column G) is \$5,235. His salary cannot exceed that number no matter how many students he has in his class. If he has an enrollment of 7 students, his salary is \$5,024. For 8 students, he will receive his **maximum salary** of \$5,235 even though the gross salary (column B) is \$5,742 for 8 students. If Professor Jones would like to receive his maximum salary of \$5,235, he would enter 8 students as his minimum.

*\***Rank/step** can be found on your contract from the Provost's Office.*
