TUE JAN 28	Deadline to submit an <u>Academic Program Change Request</u> (major/minor add/drop) for SPRING 2025 Any changes in major or minor submitted to the Registrar's office after this date will be processed for SUMMER 2025 or later unless required for SPRING 2025 degree conferral.
WED JAN 29	W grade period begins. If course starts or ends outside of the regular Spring 2025 term (1/21-5/10), the withdrawal deadline will differ. Please view the <u>drop/add and withdraw page</u> for more information.

#### • <u>(NEW: Replaces TAP numbers) Registration holds available March</u> 10<sup>th</sup>!

If you are a currently registered undergraduate student and will be looking to register for Fall 2025 classes, you will NEED to have an advisement hold removed by your academic adviser in order to register for Fall! Be sure to schedule an appointment to meet with your adviser on or after March 10<sup>th</sup> to obtain advisement and have your hold removed before your appointment time in April (the fall course listings will be available March 5<sup>th</sup>)!

### • Get the most out of MAX

#### Use the MAX student information system on the web to:

- Obtain enrollment verifications
- Check your Spring 2025 class schedule for meeting time/room/instructor
- Run a degree audit for your major
- View your grades and transfer credits

#### • Transfer Credit for Winter Courses:

If you had approval to take courses at another college this winter, have an official transcript sent to the Registrar's Office so the credits can be recorded on your MU record. Note that an <u>Authorization for the Transfer of Credit</u> form MUST be completed before you take a course at another institution.

#### • Drop/Add and Withdrawal Deadlines

If you're taking a course that meets for only part of the regular spring semester, be sure to check out the <u>Drop/Add and Withdraw website</u> for the adjusted deadlines for these sections!
