

**Dual Admissions Program Articulation Agreement
Between
Millersville University of Pennsylvania and Reading Area Community College (RACC)**

This Program Articulation Agreement is between:

Bachelor of Science in Education (BSE) PreK-4
Millersville University of Pennsylvania
Millersville, PA

and

Associate of Science (AAS) in PreK-4
Reading Area Community College (RACC)
Reading, PA

Millersville University and RACC set forth the conditions upon which Millersville University of Pennsylvania will consider graduates of the Associate of Applied Science in PreK-4 to transfer for admission into the BSE in PreK-4 at Millersville University of Pennsylvania.

Rationale for the Purpose of the Articulation Agreement

This agreement applies only to students completing the Associate of Applied Science in PreK-4 at RACC and wishing to articulate to the BSE in PreK-4 at Millersville University of Pennsylvania.

Admissions Requirements and Transfer of Academic Credit

- 1) Students enrolled in the Associate of Applied Science in PreK-4 at RACC who wish to articulate to the BSE in PreK-4 at Millersville University of Pennsylvania must complete the Millersville University of Pennsylvania admission process, including but not limited to: Millersville University of Pennsylvania admissions application, and submission of all official transcripts from secondary and post-secondary institutions.
- 2) Millersville University of Pennsylvania agrees that graduates of the (Associate of Applied Science in PreK-4 at RACC meet the admissions standards of the BSE in PreK-4 at Millersville University of Pennsylvania if they satisfy the following conditions:
 - a. Applicants with at least a 2.0 grade point average (GPA) at Associate of Applied Science are eligible for admission to Millersville University of Pennsylvania.
 - b. Prior to matriculation to Millersville University of Pennsylvania, the student will successfully complete the Associate of Applied Science in PreK-4 at RACC.
- 3) Millersville University of Pennsylvania agrees that graduates of the Associate of Applied Science in PreK-4 at RACC will be able to transfer courses and credit to Millersville University of Pennsylvania towards the BSE in PreK-4 as follows:
 - a. Per existing PA State System of Higher Education transfer policy, all students who complete the Associates of Applied Science degree at RACC and transfer into Millersville's Bachelor of Science in Education program will receive a

- waiver of Millersville's General Education requirements, with the exception of those courses listed in Appendix A of this agreement.
- b. Coursework completed at RACC towards satisfaction of the requirements for the Associate of Applied Science in PreK-4 will transfer to Millersville University of Pennsylvania as outlined in Appendix A of this agreement
 - c. All coursework transcribed at RACC beyond those outlined in Appendix A of this agreement will transfer to Millersville University of Pennsylvania and will be applied to the 120-credit total required for conferral of the baccalaureate degree at Millersville University.
 - d. All students who transfer into Millersville University through this agreement will be required to fulfill all applicable residency requirements of Millersville University and the PA State System of Higher Education current at the time of matriculation into Millersville University.

Renewal or Terminated of Articulation Agreement:

- 1) RACC agrees to promptly notify Millersville University of Pennsylvania of any substantive curricular modifications to the Associate of Applied Science in PreK-4 at RACC and further agrees that the terms of this agreement will no longer hold unless Millersville University of Pennsylvania provides a written approval that the curricular changes do not alter the intent of the agreement.
- 2) Millersville University of Pennsylvania agrees to provide RACC with information about the Bachelor of Science in Education in PreK-4 at Millersville University of Pennsylvania and any changes to the curriculum, if they should occur. Conditions for admission in the Bachelor of Science in Education in PreK-4 at Millersville University of Pennsylvania are stipulated in this agreement.


Mutual Terms and Conditions:

1. The parties agree to continue their respective policies of nondiscrimination based on Title VI of the Civil Rights Act of 1964 in regard to sex, age, race, color, creed, national origin, Title IX of the Education Amendments of 1972 and other applicable laws, as well as the provisions of the Americans with Disabilities Act. The parties agree to cooperate in the investigation of any claims of discrimination or harassment.
2. The laws of the Commonwealth of Pennsylvania shall govern this agreement. This agreement is not a legally binding contract and is not enforceable in a court or in the Pennsylvania Board of Claims. In the event of a dispute between the parties, advice and direction will be offered by the Office of the Chancellor of the State System of Higher Education.
3. The relationship between the parties to this Agreement to each other is that of independent contractors. The relationship of the parties to this agreement to each other shall not be construed to constitute a partnership, joint venture or any other relationship, other than that of independent contractors.
4. Neither of the parties shall assume any liabilities to each other. As to liability to each other for injury or death to persons, or damages to property, the parties do not waive any defense as a result of entering into this agreement. This provision shall not be construed to limit either parties' rights, claims or defenses which arise as a matter of law pursuant to any provisions of this agreement. Nothing in this Agreement shall be construed to limit


the sovereign immunity of the Commonwealth or of the State System of Higher Education or Millersville University

5. The terms of the agreement shall remain in effect, except as stipulated in certain previous terms as listed herein, for a period of five years, subsequent to the date of execution of this agreement, unless terminated by either party. Any party may terminate the agreement with or without cause, on the provision of 120 days written notice to the other party. All commitments made to students who have been accepted, but have not yet completed the program at Millersville, will be honored. In the event of a substantial breach, either party may terminate this agreement.
6. This Agreement shall only be modified in writing with the same formality as the original Agreement.
7. This Agreement represents the entire understanding between the parties. No other prior or contemporaneous oral or written understandings or promises exist in regards to this relationship. This Agreement supersedes any other agreements, restrictions, representations, or warranties, if any, between the two parties hereto with regard to the subject matter contained herein.
